



**LEICESTER CITY COUNCIL  
THE LEICESTER (CONSOLIDATION) TRAFFIC REGULATION ORDER 2006  
(AMENDMENT) (BEDFORD STREET SOUTH & FREESCHOOL LANE) LEICESTER  
(No.378 ) ORDER 2025**

Leicester City Council (the Council) in exercise of their powers under Section 1, 2, 32, 35, 45 and 46 of the Road Traffic Regulation Act 1984 (The Act) and of Part IV of Schedule 9 to the Act and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the Act hereby make the following Order:-

1. This Order may be cited as The Leicester (Consolidation) Traffic Regulation Order 2006 (Amendment) (Bedford Street South & Freeschool Lane) Leicester (No.378) Order 2025 and shall be included amongst the Orders which may be cited as The Leicester (Consolidation) Traffic Regulation Order 2006 and shall come into force on the 10<sup>th</sup> April 2025.
2. (i) The expression "the Principal Order" means "the Leicester (Consolidation) Traffic Regulation Order 2006"  
(ii) Any document referring to the Principal Order shall be construed as referring to the Principal Order as amended by this Order.
3. The Principal Order shall be amended as follows:
  - (i) In Schedule 1 to the Principal Order revoke the existing Schedules relating to  
  
Bedford Street South  
Freeschool Lane
  - (ii) In Schedule 1 to the Principal Order insert Schedule 1 to this Order in the appropriate alphabetical order.
4. Nothing in this Order shall affect the Principal Order in its operation in relation to contraventions committed before the commencement of this Order

All other restrictions on Bedford Street South and Freeschool Lane will remain unchanged

## SCHEDULE 1

### **Bedford Street South**

- Part 100 One Way Street from its junction with Byron Street to its junction with Gower Street in that direction
- Part 100 One Way Street from its junction with Lower Lee Street to its junction with Charles Street in that direction
- Part 113 Prohibition of Entry, driving and remaining of all motor vehicles at all times except for loading between its junctions with Jubilee Road and Charles Street
- Part 104 Compulsory left turn Bedford Street South into Charles Street

### North-west Side

- Part 207 from its junction with Charles Street to a point 15 metres northeast of its junction with Charles Street
- Part 308 from a point 15 metres north-east of its junction with Charles Street to a point 34 metres northeast of its junction with Charles Street
- Part 207 from a point 34 metres northeast of its junction with Charles Street to a point 4 metres north-east of its junction with Jubilee Road
- Part 400 from a point 4 metres north-east of its junction with Jubilee Road to a point 17 metres north-east of its junction with Jubilee Road
- Part 207 from a point 17 metres north-east of its junction with Jubilee Road to a point 28 metres north-east of its junction with Jubilee Road
- Part 400 from a point 28 metres north-east of its junction with Jubilee Road to a point 42 metres north-east of its junction with Jubilee Road
- Part 207 from a point 42 metres north-east of its junction with Jubilee Road to its junction with Gower Street

### South-east Side

- Part 207 from its junction with Gower Street to a point 7 metres south-west of its junction with Gower Street
- Part 211 from a point 7 metres south-west of its junction with Gower Street to a point 22 metres south-west of its junction with Gower Street

Part 207 from a point 22 metres south-west of its junction with Gower Street to its junction with Charles Street

## SCHEDULE 1

### Freeschool Lane

Part 127 from a point 65 metres north-east of its junction with Highcross Street to its eastern extremity

Part 233 from a point 65 metres north-east of its junction with Highcross Street to its eastern extremity

#### North-west Side

Part 200 from its junction with Highcross Street to a point 46 metres north-east of its junction with Highcross Street

Part 309 from a point 46 metres north-east of its junction with Highcross Street to a point 60 metres north-east of its junction with Highcross Street

Part 200 from a point 60 metres north-east of its junction with Highcross Street to a point 65 metres north-east of its junction with Highcross Street

#### South west side

Part 207 from its junction with Highcross Street to a point 23 metres east of its junction with Highcross Street

Part 200 from a point 23 metres east of its junction with Highcross Street to a point 65 metres east of its junction with Highcross Street
