

LEICESTER CITY COUNCIL (HERRICK, RUSHEY MEAD, LEICESTER) (PROHIBITION OF DRIVING AND WAITING RESTRICTIONS) TRAFFIC REGULATION ORDER 2024 (TME 2960)

NOTICE IS HEREBY GIVEN that Leicester City Council being a Civil Enforcement Area (CEA) HAS MADE an Order, under Sections 1(1), 2(1) to (3), 4(2), 5 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act"), and of all other enabling powers, and after consultation with the Chief Constable for the Leicestershire Police Authority in accordance with Part III of Schedule 9 to the Act, hereby made the following Order:-

The effects of the Traffic Regulation Order are set out in Schedule 1 to this Notice. This order will come into effect on the 10th day of June 2024

SCHEDULE 1

The effects of the Order will be to: -

- prohibit driving, all motor vehicles except permit holders, 8am to 9am and 2.30pm to 4pm from Monday to Friday inclusive on **Lockerbie Avenue**, from Gleneagles Avenue to Dalkeith Road.
- formalise School Entrance Zig-zag clearway markings on the following lengths of roads: **Arran Road**, South-east side, from 54 metres north-east of Lockerbie Avenue for 25.6 metres in a north-easterly direction; **Lockerbie Avenue**, North side, from 40 metres west of Gleneagles Avenue for 31.6 metres in a westerly direction and from 90 metres west of Gleneagles Avenue for 25.6 metres in a westerly direction. These markings prohibit stopping between the hours of 8am and 5pm Monday to Friday during School Term Time.

A COPY of the Order, the relevant plan, the Council's statement of reasons for making the Order and extract copies of the Order is available on the Leicester City Council website: www.leicester.gov.uk/trafficregulationorders

If you wish to question the validity of the Order (which was made on 5th June 2024) or of any provisions contained in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984, or on the grounds that any requirement of that Act, or of any instrument made under it has not been complied with in relation to the Order, you may, within six weeks from the 5th June 2024 apply to the High Court for this purpose.

This permanent Traffic Regulation Order replaces the Experimental Traffic Regulation Order that introduced these restrictions on the roads specified in this Notice. The Council is satisfied that the new restrictions have not been detrimental to the area.
