NOTICE IS HEREBY GIVEN that The Leicester City Council HAS MADE an Order under Sections 1, 2, 4, 5, 32, 35, 45, 46, 47, 49 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 and of all other enabling powers and after consultation with the Chief Officer of police in accordance with Part III of Schedule 9 to the Act, hereby mode the following Order:-

The effect of this Order is set out below and will be to amend the existing restrictions already in force on the streets listed below, by way of amendment to the Leicester (Consolidation) Traffic Regulation Order 2006:-

ORCHARD STREET

North east side

- 1. Revoke the existing restrictions between Royal East Street and 36 metres south east of its junction with Royal East Street
- 2. Introduce no waiting restriction from its junction with Royal East Street to a point 6 metres south east of its junction with Royal East Street
- 3. Introduce 3 hour pay and display parking Mon- Sat 7.30am-6pm, from a point 6 metres south east of its junction with Royal East Street to a point 21 metres south east of its junction with Royal East Street
- **4.** Introduce loading bay 7.30am- 6pm from a point 21 metres south east of its junction with Royal East Street to a point 36 metres south east of its junction with Royal East Street

South-west Side

- 5. Revoke the existing restrictions between Burleys Way and Royal East Street
- 6. Introduce no waiting no loading restriction from its junction with Burleys Way to a point 15 metres south east of its junction with Burleys Way
- 7. Introduce pay and display from a point 15 metres south east of its junction with Burleys Way to a point 35 metres south east of its junction with Burleys Way
- **8.** Introduce no waiting no loading restriction from a point 35 metres south east of its junction with Burleys Way to its junction with Royal East Street

If you wish to question the validity of the Order (which was made on the 7th of October 2024) or of any provisions contained in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984, or on the grounds that any requirement of that Act, or of any instrument made under it has not been complied with in relation to the Order, you may, within six weeks from 7th of October 2024 apply to the High Court for this purpose.
