THE LEICESTER (CONSOLIDATION) TRAFFIC REGULATION ORDER 2006 (AMENDMENT) (CHARLES STREET) LEICESTER (NO...) ORDER 2024

Leicester City Council (the Council) in exercise of their powers under Section 1, 2, 4, 5, 32, 35, 45, 46, 47, 49 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the Act hereby make the following Order:-

- 1. This Order may be cited as The Leicester (Consolidation) Traffic Regulation Order 2006 (AMENDMENT) (CHARLES STREET) LEICESTER (NO...) ORDER 2024 and shall be included amongst the Orders which may be cited as The Leicester (Consolidation) Traffic Regulation Order 2006 and shall come into force on the2024.
- 2. (i) The expression "the Principal Order" means "the Leicester (Consolidation) Traffic Regulation Order 2006"
 - (ii) Any document referring to the Principal Order shall be construed as referring to the Principal Order as amended by this Order.
- 3. The Principal Order shall be amended as follows:
 - (i) In Schedule 1 to the Principal Order revoke the existing Schedules relating to

CHARLES STREET

- (ii) In Schedule 1 to the Principal Order insert Schedule 1 to this Order in the appropriate alphabetical order.
- (iii) In Section 4 to the Principal Order under Parking Place Restrictions insert new part numbers as stated in Schedule 2 to this order in the appropriate numerical order
- 4. Nothing in this Order shall affect the Principal Order in its operation in relation to contraventions committed before the commencement of this Order

Part 113	Prohibition of entry, driving and remaining of motor vehicles at all times except loading the southbound carriageway between its junctions with Bedford Street South and Humberstone Gate
Part 115	Prohibition of entry driving & remaining of motor vehicles at all times except buses taxis disabled badge holders & loading the northbound

carriageway between its junctions with Rutland Street and Humberstone Gate

Part 327 ELECTRIC VEHICLE CHARGING PARKING POINT

No person shall cause or permit a vehicle to wait in any road or length of road to which this restriction is applied except for an Electric Vehicle. The sole purpose of the electric vehicle waiting within the parking place is for the recharging of the vehicle only, by the use of the electric charge point provided for that parking place. The charging of the vehicle between 7.30am to 6pm is limited to a maximum period of 1 hours with no return within 1 hour.

All electric vehicles must be parked wholly within the parking bay marked on the carriageway. Whilst parked in the parking bay no person shall carry out any work relating to the construction or repair of the vehicle other than may be necessary to enable the electric vehicle to be moved from the parking bay. No person shall allow an electric vehicle waiting in a parking bay to be used for or in connection with the sale of any electric vehicle or any other article or for the offer of any service for reward.

All electric vehicles must be parked wholly within the parking bay marked on the carriageway. Whilst parked in the parking bay no person shall carry out any work relating to the construction or repair of the vehicle other than may be necessary to enable the electric vehicle to be moved from the parking bay. No person shall allow an electric vehicle waiting in a parking bay to be used for or in connection with the sale of any electric vehicle or any other article or for the offer of any service for reward.
