

LEICESTER CITY COUNCIL (HAWARDEN AVENUE AND ROBINSON ROAD, LEICESTER) (NO WAITING - NO LOADING PROHIBITIONS) (AMENDMENT NO.XXX) TRAFFIC REGULATION ORDER 2025

Leicester City Council (hereinafter referred to as "the Council") in exercise of their powers under Sections 1, 2, 4 and 5 of the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the Act hereby make the following Order:-

- This Order may be cited as the Leicester City Council (Hawarden Avenue and Robinson Road, Leicester) (No Waiting – No Loading Prohibitions) (Amendment No.XXX) Traffic Regulation Order 2025 and shall be included among the Orders which may be cited as The Leicester (Consolidation) Traffic Regulation Order 2006 and shall come into operation on the ## day of #### 2025.
- 2. (i) The expression "the Principal Order" means "The Leicester (Consolidation) Traffic Regulation Order 2006"
 - (ii) Any document referring to the Principal Order shall be construed as referring to the Principal Order as amended by this Order.
- 3. The Principal Order shall be amended as follows:
 - In Schedule 1 to the Order insert the schedules hereto in the appropriate alphabetical order.
- 4. Revoke only the restrictions in the Principal Order and its subsequent amendments in so far as they impose restrictions on the following road. Restrictions imposed by that Principal Order on other roads will remain in force.
 - Hawarden Avenue and Robinson Road.
- 5. Nothing in this Order shall affect the principal Order in its operation in relation to offences committed before the commencement of this Order.
