



## LEICESTER CITY COUNCIL

### **THE LEICESTER (CONSOLIDATION) TRAFFIC REGULATION ORDER 2006 (AMENDMENT) (ST PETERS ESTATE DROPPED KERBS) (No.3\*\*) ORDER 2025**

Leicester City Council (hereinafter referred to as “the Council”) in exercise of their powers under sections 1, 2, 4, 5, of the Road Traffic Regulation Act 1984 (“the Act”) and of Part IV of Schedule 9 to the Act and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the Act **hereby makes the following Order: -**

1. This Order may be cited as The Leicester (Consolidation) Traffic Regulation Order 2006 (Amendment) (St Peters Estate Dropped Kerbs) (No.3\*\*) Order 2024 and shall be included amongst the Orders which may be cited as The Leicester (Consolidation) Traffic Regulation Order 2006 and shall come into operation on xx of xx 2025.
2.
  - (i) The expression “the Principal Order” means “The Leicester (Consolidation) Traffic Regulation Order 2006”
  - (ii) Any document referring to the Principal Order shall be construed as referring to the Principal Order as amended by this Order.
3. The Principal Order shall be amended as follows: -
  - (i) Revoke only the restrictions in the Principal Order and its subsequent amendments in so far as they impose restriction on the following roads: Apollo Court; Atlas Close; Berners Street; Jupiter Close; Mensa Close; Pegasus Close; Pluto Close; Polaris Close; Taurus Close, & Vostock Close
  - (ii) In Schedule 1 to the Principal Order insert Schedule 1 hereto in the appropriate alphabetical order.
4. Restrictions imposed by that Principal Order on other Roads will remain in force.
5. Nothing in this Order shall affect the principal Order in its operation in relation to contraventions committed before the commencement of this Order.

**SCHEDULE 1**

**Apollo Court**

Eastern Side

Part 207 from its junction with Apollo Close to a point 5 metres south-east of a point in line with the back of footway in front of 19 to 57, Apollo Close

Part 207 from a point 5 metres south-west of a point in line with the property boundary between 8 & 10 Apollo Court to a point 10 south-west of a point in line with property boundary between 8 & 10 Apollo Court

Western Side

Part 207 from a point 5 metres north-east of a point in line with the property boundary between 13 & 15 Apollo Court to a point 10 north-east of a point in line with the property boundary line between 13 & 15 Apollo Court

Part 207 from a point 3 metres south of a point in line with the north-eastern boundary of 2/12 Apollo Court to its junction with Apollo Close

**Atlas Close**

#### North Side

- Part 207 from a point 2 metres west of the western boundary of number 2 Atlas Close to its eastern extremity including the turning head but excluding the parking bays

#### South Side

- Part 207 from its eastern extremity to a point 3 metres west of its eastern extremity
- Part 207 on the eastern side of its junction with Apollo Close from a point 2 metres east of the western boundary of number 2 Atlas Close to its junction with Apollo Close
- Part 207 on the western side of its junction with Apollo Close from a point 12 metres north of a point in line with the north-eastern property boundary wall of 79, Maidstone Road to its junction with Apollo Close

#### West Side

- Part 207 from its junction with Apollo Close to a point 16 metres north of its junction with Apollo Close**

### **BERNERS STREET**

- Part 100 One Way Street from its junction with Melbourne Road to its junction with Breedon Street in that direction

#### North Side

- Part 207 from a point 3 metres north-west of its junction with Maynard Road to a point 3 metres south-east of its junction with Maynard Road
- Part 207 from a point 5 metres north-west of its junction with Keythorpe Street to a point 5 metres south-east of its junction with Keythorpe Street
- Part 207 from a point 3 metres north-west of its junction with Wilson Street to a point 3 metres south-east of its junction with Wilson Street
- Part 207 from a point 5 metres north-west of its junction with Melbourne Road to a point 8 metres east of its junction with Melbourne Road

#### South Side

- Part 207 from the east side of its junction with Breedon Street to a point 1 metre west of its junction with Breedon Street

Part 207 from a point 8 metres east of its junction with Melbourne Road to a point 5 metres north-west of its junction with Neptune Close

Part 207 from a point 5 metres south-east of its junction with Polaris Close to a point 5 metres north-west of its junction with Polaris Close

Part 207 from a point 10 metres south-east of its junction with Taurus Close to a point 10 metres north-west of its junction with Taurus Close

**Part 207 from a point 42 metres north west of its junction with Taurus Close to a point 47 metres north west of its junction with Taurus Close**

Part 207 from a point 5 metres south-east of its junction with Jupiter Close to a point 5 metres north-west of its junction with Jupiter Close

Part 207 from a point 5 metres south-east of its junction with Maidstone Road to its junction with Maidstone Road

### **JUPITER CLOSE**

North & West Side

Part 207 from its junction with Maidstone Road to its junction with Berners Street

South & East Side

Part 207 from its junction with Berners Street to a point 5 metres south of its junction with Berners Street

**Part 207 from a point 28 metres south of its junction with Berners Street to a point 32 metres south of its junction with Berners Street**

**Part 207 from a point in line with the property boundary of 13/15 Jupiter Close to its junction with Maidstone Road**

### **Mensa Close**

North side

**Part 207 from a point 23 metres west of its junction with Melbourne Road to a point 28 metres west of its junction with Melbourne Road**

Outer Side

Part 207 from a point 43 metres west of its junction with Melbourne Road to its junction with Melbourne Road

### **Pegasus Close**

#### Northern Side

Part 207 from 2 metres west of the south-west corner of number 6 Pegasus Close to 2 metres east of the south-east corner of number 16 Pegasus Close

**Part 207 From a point 13 metres west of the south-east corner of number 16 Pegasus Close to its eastern extent excluding the parking area owned by housing**

#### Southern Side

**Part 207 From its eastern extremity to a point 7 metres west of its eastern extremity**

**Part 207 From a point 5 metres west of a point in line with the property boundary between 17/19, Pegasus Close to a point 10 metres west of a point in line with the property boundary between 17/19 Pegasus Close**

**Part 207 on the eastern side of its junction with Vostock Close from a point 9 metres west of a point in line with the western boundary of 1/9, Pegasus Close to its junction with Vostock Close**

Part 207 on the western side of its junction with Vostock Close from a point 22 metres north of a point in line with the northern boundary of 2/6, Vostock Close to its junction with Vostock Close

### **Pluto Close**

#### Inner Side

Part 207 from its eastern extremity to a point 22 metres west of its eastern extremity

Part 200 from a point 79 metres west of its eastern extremity to its junction with Guthlaxton Street

#### Outer Side

**Part 207** from a point 12 metres south of a point in line with the property boundary of 34/36 Pluto Close to a point 8 metres south of a point in line with the property boundary line of 34/36 Pluto Close

**Part 207** from a point 9 metres north of a point in line with the property boundary of 34/36 Pluto Close to a point 14 metres north of a point in line with the property boundary line of 34/36 Pluto Close

**Part 207** from a point 20 metres north of the northern property boundary of number 52 Pluto Close to its eastern extremity

### **POLARIS CLOSE**

#### North-west Side

**Part 207** from a point 60 metres south-west of its junction with Berners Street to its junction with Berners Street

#### South-east Side

**Part 207** from its junction with Berners Street to a point 5 metres south-west of its junction with Berners Street

**Part 207** from a point 26 metres south-west of its junction with Berners Street to a point 31 metres south-west of its junction with Berners Street

#### South-west Side

**Part 207** from a point 4 metres north-west of a point in line with the property boundary line between 50/52 Polaris Close to a point 9 metres north-west of a point in line with the property boundary line between 50/52 Polaris Close

### **TAURUS CLOSE**

#### Inner Side

**Part 207** from its north-west extremity excluding the parking bay to a point 12 metres south-east of its north-west extremity

**Part 207** from a point 4 metres south-east of a point in line with the property boundary line between 53/55 Taurus Close to a 9 metres south-east of a point in line with the property boundary line between 53/55 Taurus Close

**Part 207** from a point 4 metres north-east of a point in line with the property boundary line between 21/23 Taurus Close to a point 9 metres north-east of a point in line with the property boundary line between 21/23 Taurus Close

Part 207 from a point 5 metres south of its junction with Berners Street to its junction with Berners Street

Outer Side

Part 207 from its junction with Berners Street to its north-west extremity excluding the parking bay

### **Vostock Close**

Inner Side

**Part 207** from its junction with Pegasus Close to a point 7 metres west of its eastern extremity

Outer Side

**Part 207** from its eastern extent to a point 10 metres west of its eastern extent

**Part 207** From a point 4 metres west of a point in line with the property boundary line between 43/45 Vostock Close to a point 9 metres west of a point in line with the property boundary line between 43/45 Vostock Close

Part 207 from a point in line with the western property boundary of number 39 Vostock Close to a point 15 metres south of a point in line with the southern property boundary of number 16 Vostock Close

Part 207 from a point 22 metres north of a point in line with the southern property boundary of number 16 Vostock Close to its junction with Maidstone Road including its junction with Pegasus Close
