### THE LEICESTER (20 MPH SPEED LIMIT) (HOME FARM AREA) ORDER 2025

**NOTICE IS HEREBY GIVEN** that Leicester City Council proposes to make an Order under Sections 84(1) and 84 (2) of the Road Traffic Regulation Act 1984. The effect of this Order is to prohibit any motor vehicle from travelling at a speed exceeding 20 miles per hour along the lengths of road as set out below:
