# THE LEICESTER (CONSOLIDATION) TRAFFIC REGULATION ORDER 2006 (AMENDMENT) (DOVER STREET) LEICESTER (No.374) ORDER 2025

Leicester City Council (the Council) in exercise of their powers under Section 1, 2, 4, 5, 32, 35, 45, 46, 47 and 49 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the Act hereby make the following Order **IN PART**:-

- (i) This Order may be cited as 'The Leicester (Consolidation) Traffic Regulation Order 2006 (Amendment) (Dover Street) Leicester (No.374) Order 2025' and shall be included amongst the Orders which may be cited as The Leicester (Consolidation) Traffic Regulation Order 2006 and shall come into force on the 23rd February 2025.
  - (i) This order is made in part. The first made order which excluded Dover Street is titled 'The Leicester (Consolidation) Traffic Regulation Order 2006 (Amendment) (Calais Street, Chatham Street, Granby Street And York Street) Leicester (No.350) Order 2024'
  - (ii) The expression "the Principal Order" means "the Leicester (Consolidation) Traffic Regulation Order 2006"
  - (iii) Any document referring to the Principal Order shall be construed as referring to the Principal Order as amended by this Order.
- 3. The Principal Order shall be amended as follows:
  - (i) In Schedule 1 to the Principal Order revoke the existing Schedules relating to;

## DOVER STREET

- (ii) In Schedule 1 to the Principal Order insert Schedule 1 to this Order in the appropriate alphabetical order.
- 4. Nothing in this Order shall affect the Principal Order in its operation in relation to contraventions committed before the commencement of this Order

## SCHEDULE 1

## DOVER STREET

Part 112 Prohibition of motorised vehicles from its junction with Granby Street to a point 26 metres south west of its junction with Granby Street

### North-west side

- Part 207 From its junction with Wellington Street to a point 10 metres north-east of its junction with Wellington Street
- Part 400 From a point 10 metres north-east of its junction with Wellington Street to a point 46 metres north-east of its junction with Wellington Street
- Part 207 From a point 46 metres north-east of its junction with Wellington Street to a point 55 metres north-east of its junction with Wellington Street
- Part 400 From a point 55 metres north-east of its junction with Wellington Street to a point 65 metres north-east of its junction with Wellington Street
- Part 207 From a point 65 metres north-east of its junction with Wellington Street

to a point 53 metres north-east of its junction with Albion Street

Part 211 From a point 53 metres north-east of its junction with Albion Street to a

Point 64 metres north-east of its junction with Albion Street

- Part 308 From a point 64 metres north-east of its junction with Albion Street to a point 84 metres north-east of its junction with Albion Street
- Part 200 From a point 84 metres north-east of its junction with Albion Street to a point 26 metres south west of its junction with Granby Street

#### South-east side

- Part 207 From a point 26 metres south-west of its junction with Granby Street to a point 7 metres south-west of its junction with Calais Street including the turning head
- Part 400 From a point 7 metres south-west of its junction with Calais Street to a point 35 metres south-west of its junction with Calais Street
- Part 207 From a point 35 metres south-west of its junction with Calais Street to its junction with Wellington Street
