

**Leicester City Council (Parking Articles, Leicester) (Articles for Mapped Parking Prohibitions, Restrictions and Provisions) Traffic Regulation Order 2024**

**NOTICE IS HEREBY GIVEN** Leicester City Council ("the Council") proposes to make an Order under Sections 1(1), 2, 4, 5, 32, 35, 35A, 45, 46, 47, 49, 122 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers, and being satisfied that after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby propose to make the following Order:-

1) To introduce new interpretations related to map schedules: -

- "Appendix A" consists of Tariff table showing the level of Parking Charges for Designated Parking Places and applies to this Order;
- "As Specified in the Map Schedule" means the Waiting, Loading and Stopping prohibitions and restrictions, or the parking provisions being Designated Parking Places, Parking Places (specified classes of vehicle), Loading Places and Parking Areas designated by this Order and identified in the Map Tiles listed at Schedule 2, which in conjunction with the Map Tile Labels and/or the Map Schedule Legend, identifies each particular type of prohibition, restriction, parking provisions and certain of its governing provisions;;
- "Map Schedule" means the Map Tiles in conjunction with the Map Schedule Legend attached to this Order and listed in Schedule 2: Provided that the Council does not accept responsibility for inaccuracies contained in the Ordnance Survey data relied upon to create the Map Schedule and where a Prohibition, Restriction, Designated Parking Place, Parking Place, Loading Place or Parking Area is depicted on the Map Schedule, that provision continues to apply irrespective of any subsequent changes that have been made to the underlying Ordnance Survey data;
- "Map Schedule Legend" means the Map Schedule Legend to this Order which, when used in conjunction with a Map Tile as listed in Schedule 2, identifies the specific types of Waiting, Loading and Stopping Prohibitions and Restrictions and the Designated Parking Places, Parking Places, Loading Places or Parking Areas designated by this Order and, where appropriate, certain of their governing provisions;
- "Map Tile" means an individual Map Tile with a specific Map Tile Reference, being part of the Map Schedule as listed in Schedule 2 to this Order;
- "Map Tile Label", where shown on a Map Tile forming part of the Map Schedule in relation to Waiting, Loading or Stopping prohibitions or restrictions or a Designated Parking Place, Parking Place, Loading Place or Parking Area, means a label which indicates the type of provision and, if appropriate, certain of its governing conditions;
- "Prohibited Road" means any of the sides or lengths of roads As Specified in the Map Schedule as having a prohibition of Waiting, or a prohibition of Waiting and Loading, or a Restricted Footway, Restricted Footway Zone, Controlled Parking Zone or Restricted Parking Zone, during the Prohibited Hours, provided that the expression "Prohibited Road" shall not include any Designated Parking Place or Parking Place when operational;
- "Restricted Road" means any of the sides or lengths of roads As Specified in the Map Schedule as having a restriction of Waiting, or a Waiting and Loading restriction, Restricted Footway, Restricted Verge, Controlled Parking Zone or Restricted Parking Zone during the Restricted Hours so specified, provided that the expression "Restricted Road" shall not include any Designated Parking Place or Parking Place when it is operational;

2) To amend all Articles within both Part II & Part III affecting Prohibitions or Restriction of Waiting, Loading and Stopping, in addition to parking provisions, by introducing the interpretations such as 'As Specified in the Map Schedule'. Examples shown below: -

- Save as provided in Article 12 to 21, no person shall, except upon the direction or with the permission of a police officer in uniform, cause or permit any Vehicle to Wait at any time on a Prohibited Road As Specified in the Map Schedule, when a prohibition on Waiting or Waiting on a Footway or Verge is in effect. For the avoidance of doubt, where the prohibition on Waiting is shown by a road marking (1018.1 – S7-4-1) it shall not include the limits of a lay-by or parking place, unless the road marking is painted within the limits of the lay-by or parking place.
- The parts of roads As Specified in the Map Schedule as Parking Places, Parking Bays or Parking Areas and marked out and signed for the use therein of specified classes of Vehicles are hereby designated to be used subject to the following provisions of this Order as Parking Places, Parking Bays or Parking Areas on such days and during such hours and subject to any other provisions governing their use As Specified in the Map Schedule. Vehicles shall park wholly within the limits of the bay markings.

3) To revoke existing parking articles covering Prohibitions, Restrictions and Provisions for both Consolidation Orders of 1975 and 2006.

The parking articles introducing new interpretations and reference to map schedules, tiles and key. A new style tariff table (Appendix A) has been included that reflects the current parking charges for payment bays. In addition, an interpretation for a Prohibited and a Restricted Road has been provided to help with understanding within the Order. This Order does not introduce any new parking prohibitions, restrictions or provisions within the City of Leicester. The new articles will support Map Schedules under a new Consolidation Order that will be introduced later this year.
